We have been following up local govt. plans for free ration, Shiv Thali, etc. In the meanwhile, there is a multitude of people, who are deprived of food, medical and other basic provisions. We do the best we can.

The road line mapped for our relief services is Meri, Mhasrul, Makhmalabad, Peth Road, Nashik-Adgaon Flyover and Panchavati, populated with poor slum dwellers, rag pickers, migrants and daily wage labourers, etc.
